- 3. Security/Fire Alarm systems discussion made regarding quotes. Clerk to contact all parties and see if they can come to next work session to answer questions on pricing/information. Moved to next work session.

Motion by Pipes to accept 2 applications for VFD Tucker 2nd motion carried. Working on another \$4000 grant. Going to be sending 2 firefighters to Jasper in a few weeks for training. April 27th-29th FDIC conference in Indianapolis. Fire Dept purchases 4 passes for members to go and view. Chicken Noodle dinner March 18th 4p-7p. Free will donation. Award to cadet Jeremiah Cromisfor help in an emergency situation-great job! Cadet program is 14-18yrs old. Working with Mr. Bellew at the high school to help grow our cadet program.
- 4. Utility Manager (Hines)
 - a. Street-Meeting with INDOT to fix 40 through town. Discussion started to work on fixing road properly.
 - b. Water Since we fixed the broken main saving about 750,000 gallons of water. Called in Environmental contracting due to closeness of fiberoptic and gas lines. Working on flushing hydrants this year.
 - c. Wastewater/Stormwater-Working on sanitary lids to make sure they are in good shape.
 - d. Electric -Started replacing poles looking at 27-30 poles this year.
 - e. Other painting of buildings and mowing coming with spring coming in. Pipes discussed Main Street organization. Community coming together and ready to move forward making our community beautiful. We have new businesses and current businesses that are bringing things to the table.
