Choice One Engineering –surveys and legals for right of way acquisition. Possibly to have Choice One Engineering look at the culvert to see cost estimates.Have Gene call Choice One to see about a review on Elm Drive culvert. Bring Stormwater Resolution 2018-01 to table regarding stormwater match for OCRA. **Motion** by Gary Killen to adopt SW Resolution 2018-01. Jim Lafuze – 2nd – motion carried. Will have a public hearing on January 23rd, 2018 at 5:00pm with a meeting directly after 5:30pm.

- o **Other** – Brian Haber got the ditch done on Eliason. Some discussion on Ordinance 2004-02. Questions on what needs to get prior approvals for purchase.
 - At drainage board meeting in December it was mentioned that the town needs to look at the outfall of Elm Creek to the Centerville road runoff. (Nature Lab).
