  - Stormwater update – A lot of work has been done in trying to get the information done for the Stormwater grant. The application will be put in this week.
  - Utility work update and needs – extremely short with people sick. Trash pickup has been short. Was able to put some cold mix down on some potholes in town. Streets are in need of repair. Centerville road needs repair from Water plant to I-70. Life expectancy of road has passed. Need to look at the needs in the town. Town garage roof needs work. Garage parking lot needs work. With salt being in garage, there are multiple issues. This needs addressed. Since being short staffed, one council member has been helping out. Water mains – have had 7 since January 1<sup>st</sup>. Water towers need inspected. Information on facility charge and possibility of adding this to the invoice. Look for more information on this.
  - Bldg commissioner – met with engineer on Main St. bridge. Issues and concerns. Will have updates in future meetings.
  - The town council is looking for volunteers to be on Plan Commission. Non Republican. Contact the clerk's office for more information. Discussion on area of Centerville and information on getting cost on fiscal plan for Plan

Commission. Also information on survey cost. Updates to come in future meetings.
