**Unfinished items:**

- o Timeclock update –Discussion on getting clocks and mobile clock-in. Information handed to Town Manager to handle. Town manager to handle location setup, etc. **Motion** to move forward with PayChex by Pipes. Holbert 2<sup>nd</sup> – motion carried.
