

**MINUTES
COUNCIL MEETING
MARCH 12, 2013**

The Centerville town council met in regular session on Tuesday, March 12, 2013, in the Municipal Building, 204 E. Main St., Centerville, IN 47330.

The meeting was called to order at 7:17 p.m. with Pres. Wandersee presiding.

MOTION to approve the minutes of February 12, 2013, was made by Pres. Wandersee and seconded by Council Johnson-Keep. With all in favor and no abstentions, motion carried.

MOTION to pay the bills was made by Pres. Wandersee and seconded by Council Johnson-Keep. With all in favor and no abstentions, motion carried.

Russ Turner, RMD Patti Insurance, was present to explain the town's insurance policy. He explained the slight increase is on the addition of the police building east of town. With changes, premium is up around 5%. Copies of the loss history is near the back of the proposal. **MOTION we put this on the agenda for the work session to be held April 2nd at 6:00 p.m.** was made by Pres. Wandersee and seconded by Council Johnson-Keep. With all in favor and no abstentions, motion carried.

MOTION to pay the worker's comp. insurance package due to the due date being soon was made by Pres. Wandersee. Russ added that we were strapped with a higher premium over the past four years due to a former loss. We are being issued a 12% credit on the premium. Motion was seconded by Council Johnson-Keep. With all in favor and no abstentions, motion carried.

Gene Kates gave the building commissioner report showing five (5) permits for a total of \$241.

Police Chief Ed Buchholz gave the police report: Criminal investigations: 1 intimidation; 4 theft; 1 forgery; 2 leaving the scene of an accident; 1 sexual battery; 1 sexual misconduct with a minor; 1 battery; 1 fraud; 2 criminal mischief; 1 domestic battery. Arrests: 1 leaving the scene of a property damage accident; 2 driving while license suspended; 2

delinquency, possession of marijuana; 2 delinquency, theft; 2 warrant arrests. K-9 usage: 4 (includes one arrest for possession of marijuana by Cambridge City Police Department). There were 7 total accidents investigated; 25 total vehicle stops; 9 state tickets issued; 158 total calls; 3,981 total mileage.

WATER/FIRE DEPARTMENTS

MOTION to pay the bills was made by Council Johnson-Keep and seconded by Council Widau. With all in favor and no abstentions, motion carried.

Deputy Fire Chief, Gary Locke, gave the fire report for February:

WASTEWATER/STORMWATER DEPARTMENTS

MOTION to pay the bills was made by Council Johnson-Keep and seconded by Council Widau. With all in favor and no abstentions, motion carried.

MOTION to allow a \$125.78 refund to Marshall Bricker, 303 Linden Drive was made by Council Johnson-Keep and seconded by Council Widau. With all in favor and no abstentions, motion carried.

Terry Stover, utility supervisor, reported a possible water leak in the 600 block of East School Street that may possibly be going into a sanitary sewer line. Reports are showing the flow in both water and sewer to be elevated in a 24-hour test period. They are going to try to listen it out when weather permits. If it is not found quickly, help may be needed.
