  - Motion by Pipes to have town pay for the following cell phones & jetpacks (4 to Dept heads F/D, P/D, Utility Manager & Clerk, 4 basic phones for Water, Wastewater, Electric & Building commissioner. 11 jetpacks(CORRECTION) 2 for F/D, 7 for P/D, 1

for Water, 1 for Wastewater. Employee must follow Cell phone policy in Resolution 2014-11. Holbert  $-2^{nd}$ . Motion carried.

- 7. <u>CYL opening day parade</u> CYL asking permission to have a parade on May 13<sup>th</sup> @ 11am. Motion by Bodiker to have parade. Tucker 2<sup>nd</sup>-motion carried.
- 8. OtherDiscussion on tagging of equipment. Tucker & clerk to get side by side information for council.
  - Motion by Wandersee to allow banners to be hung on Centerville poles for Veteran's Clove project- would be up a little over a month. Holbert & Tucker 2<sup>nd</sup> motion carried.

## **Department Reports**

- 1. Building Commissioner— (Kates)see report. Update talked with Casey's they are being held up with INDOT. They hope to have everything moving soon. Edward Jones pulled permits. Panoramic moving forward with their remodeling. Different builders are looking at quotes for buildings in the Centerville area.
- 2. Police Department (Buchholz) see report. 18 applicants for opening. Going through application process. Utility emp. Working on windows at P/D. Grant was submitted last week.
- 3. Fire Department—(Spears) see report. Did complete ISO review. Had several good ideas to improve/make things easier. He said we probably won't get any results til end of summer but it looks good. Rec'd two more donations for Rhea Toschlog. One is \$100 and one is \$50. Cadets to join Sheriff dept cadets for training this week. Mr. Baloo at high school is working on helping recruit cadets.
- 4. Utility Manager (Hines)
  - a. Street—see report. Streets list is put together and ready for CC grant if it becomes available Discussion on patching needed spots in town.
  - b. Water see report. Hydrant is moved on Gaar Jackson. Also with Gaar Jackson project have poles ordered and everything is in. Hopefully project to start the 20<sup>th</sup> of April.Still having some issues with right away. County is dealing with this issue.
  - c. Wastewater/Stormwater-Had a #2pump in the head works went down. It's out and ready to be sent out. For a new pump \$18,000. To repair is either \$7,900 and \$4,282. We are moving forward with \$4,282. The CSO audit came back good with a few minor changes. Beginning jetting on a regular basis to keep up maintenance schedule. Working on trash spec sheet to get quotes. Trash and trash & recycling.
  - d. Electric –. Mtg with Duke on project for 2018. Town will need to move 3+ poles. Duke will move the poles and we will move our lines to those poles using IMPA. Park –guys have been working on burying lines for future use. Bathrooms will be available later this month. Touched base with Jackie onplanters. They should be in soon and we can get the planters out and taken care of. Flags to be replaced throughout town on town buildings. More poles have been reset throughout town.
- 5. Clerk-Treasurer (Dillman) Worker's Comp insurance information.
- 6. Close motion by Wandersee to close meeting. Tucker, Bodiker 2<sup>nd</sup> motion carried.
