## G. Killen called mtng to order @4:10

- Eliason Rd runoff Ned & Gene gave current update on runoff. Met with property owner/Haber Farms. Shared maps of RR bed removal and improved water runoff by Haber Farms. Concern of additional water coming into now standing 2 tiles/if they will hold. Later decision will have to made on tiles. Build comm. Opinion is that the Harber tiles will hold the water. Building comm. Recommended that adjacent land owners will need to be notified of changes made by Harber Farms.

Mgmt came, inspected; waxing company did not fully admit to disposal of wax. Report initiated from Facebook.
  - -Maplenut Ct investigation-ungerground fuel oil tank. 50-70 gallons of fuel/oil is suspected spill. Landscaper broke off cap and rain spilled fuel into Crown Creek. Rain water diluted spill. Ned contacted EMA/IDEM advised. Fuel to be pumped out at owner's expense.
  - **-Ditch Cleaning** Elm creek ditch progress. 1<sup>st</sup> cutting complete. Ned suggested 2<sup>nd</sup> cutting to be postponed until cleaning of settlement in ditch is complete. Ned is waiting for appraisal of cleaning.
