- Approve Minutes–Holbert motion to approve 2/13 minutes, 3/6 minutes from previous meetings.

Old Business

1. Resolution 2018-01 small purchase policy– Motion by Tucker to suspend rules and move to third and final reading for Resolution 2018-02. Roll call. 4 ayes – no nays. Pipes makes motion to move to adopt and read by title only. Tucker – 2nd – motion carried.
2. Time Clock update–Putting together cost evaluation and will forward to council.
3. CYL– Update – CYL has been working on paperwork.
4. Update on job descriptions–Town Manager job description discussion. Additions from attorney to be added by clerk. Motion by Holbert to move to publish job notice for Town Manager by end of this week. Tucker – 2nd – motion carried. Clerk to publish job notice this week.
5. Trash Rate Study–Discussion on trash. Info will be in April council meeting. Clerk working with Attorney to get bid specs for outsourcing to council.
6. Reach alert system/One Call system– still in progress.
7. Ordinance 2018-04 - Bond issuance ordinance–For CSO/SRF loan. Motion by Pipes to move ahead and read by title only. Tucker – 2nd – motion carried. Motion by Pipes suspend rules and regulations and read by title only – Tucker – 2nd – motion carried. Roll call. 4 ayes – no nays. Motion by Pipes to accept Ordinance 2018-04. Tucker – 2nd – motion carried.
8. Gaar Jackson Rd Interlocal agreement - Attorney would like to be able to discuss with clerk in detail what happens. Motion by Holbert to have attorney Martin to work with clerk on details of Interlocal agreement. Tucker – 2nd – motion carried.
9. Ordinance 2018-05- bond appropriation for GO bond& Interlocal agreement–Motion to introduce Ordinance 2018-05 for GO Bond obligation by Pipes. Tucker – 2nd – motion carried. Motion suspend rules and regulations for Ordinance 2018-05 by Holbert and read by tiles only. Pipes – 2nd – motion carried. Motion by Holbert on Ordinance 2018-05 to move for adoption. Tucker 2nd – Roll call. 4 ayes – no nays – motion carried.
10. Other – Plan Commission had a proposed plan from Wabash Scientific Engineering – Motion by Tucker to go ahead with Wabash Scientific to have a fiscal plan. Pipes 2nd – motion carried. Discussion on topic.

Centerville. Have had good attendance at their meetings. Looking for volunteers to be a part of this group. Meetings are 2nd Thursday of each month @ Turner Insurance (new) building @ 6pm. Discussion on flower pots and moving them back. Main Street group would take care of the planting/care of pots during the year. Asking for the town to help get this done.

Motion by Pipes to accept CYL parade May 12th @ 11am. Holbert - 2nd - motion carried. Anthony and Chris have finished their training and will now be able to help cover shifts for police.


