- o Timeclock update –Awaiting information from vendors. March 22nd - Clerk to view webinar on KeyTracks (Keystone). Will bring info to council in future meeting. Paychex another program looking into.

- o Trash rate study update - Jeff Rowe/Umbaugh – Initial rate study done and have since added information on outsourcing trash as well as option to keep truck or go to new – one man truck. 

  - Resolution 2018-07 Signatory Auth Resolution - for CSO project & SRF loan papers – **Motion** by Wandersee to accept Res 2018-07. Holbert & Tucker – 2<sup>nd</sup> – motion carried.
  - Marilyn Buchholz for Veteran's Day parade – Discussion on Veteran's Day parade May 19<sup>th</sup>, 2018 at 6:00pm. Motion by Holbert to approve parade and route same as last year and put up banners – 2<sup>nd</sup> – Tucker – motion carried. Banners on poles up by May 1<sup>st</sup> if possible.
  - Ed Martin – Interlocal agreement for Gaar Jackson Rd project – Council to look at information forwarded and have decision ready by March 13<sup>th</sup> council meeting. **MOVE** to council meeting.
  - Bodiker – discussion on looking at part-time help. **Motion** by Holbert to move forward in hiring part-time help for trash – Wandersee – 2<sup>nd</sup> – motion carried. Bodiker and one other council member to do hiring process.
  - Gene Kates – Comcast wanting to put a buried service line in town. Reviewed project and found Comcast needs right away permits and they are needing right ways from residents on who the lines will cross properties. Have let Comcast know that they needed to send a letter to the council to get approval. Then they can get approval and move forward after showing they have obtained approval of property owners and towns.
  - Gene Kates – Also had stormwater special meeting and stormwater board approved study to be done on Morton bridge and also received poplar street analysis back. Discussion on stormwater updates.
  - Discussion on new signs in town – question on permits.
  - Anthony Smith – utility information. Lots going on – Electric – maintainable on 20+ street lights and power outage in various areas. Water – have had some issues with the plant. Main plant down for a few days – had a sensor malfunction. There is an engineering problem in the plant – it needs to be updated so that we won't have these issues. B. Markley and S. Phenis are looking at options. Ran off east well for 4 days. Towers need work done on them. There is a list of must do – need to do, etc. Still don't know where the break is – if we even have one. Fixed a leak at Casey's – We need to get a licensed water plant operator. There is a leak at the rest area. That will be looked at in warmer weather. Wastewater – need another licensed plant operator. Trash – need to look at those with CDL's. Street – needs more cold mix. Discuss with Street liaison. Wastewater – needs are there as well. – Updates will continue.
  - Holbert – **Motion** to accept the facts on the job performance review on the Utility Manager – Wandersee – 2<sup>nd</sup> – motion carried. **Motion** to suspend and terminate Utility Manager – Wandersee 2<sup>nd</sup> – motion carried. Will pay all unpaid leave. **Motion** to advertise for Town Manager position. Wandersee – 2<sup>nd</sup> – motion carried. Tucker – asked on severance. Discussion on this. In the past – it has been given vacation, etc.
  - Bodiker – to send out job description on Town Manager to other council members, attorney and clerk. **MOVE** to council meeting to approve/discuss.


