- o **Memorandum** – 1/9/18, 1/23/18 spec mtg, 2/19/18 spec mtg, 2/26/18 spec mtg.
- o **Scott Studebaker** – concern –Happy to be in Centerville. Huge concerns with culvert put in beside property.Culvert on Rader property. Over the last 2 years it has flooded over 5 times and has had a huge impact financially to the homeowner. What can be done to help this situation? Property owners have done so much to try to help the issues of flooding. G. Kates discussed studies that have been done. Discussion on water runs in areas east of Centerville. Asking for more discussion. Stormwater board to continue discussion for possible options for this area. G. Kates to talk to homeowner re: culvert size. Moved to future meetings.
- o **Randy Boswell** – did not come.
- o **Quarterly reports/clerk information** –discussion and questions answered.
- o **Ditch cleaning on N. McMinn& College Corner**–update –Kates had conversation with County and they clean their portion but don't want to be involved in the town area. G. Kates got an estimate for \$1,485 from KAF to clean out overgrowth and trash from ditch. Discussion on dumping in that ditch as well as others in area.Possible options to deter dumping. **Motion**by Lafuzeto accept estimate for ditch cleaning by KAF for \$1,485. Killen – 2nd – motion carried.
- o **Stormwater grant update** – Did not get grant – OCRA going to meet with town to discuss information.Meeting will happen @ 11:30am on Friday April 13th. Discussion on future opportunities and questions for Kenna and OCRA. Bring information back to board.**Motion** by Killen to purchase 3 small easements (Godfrey, Hicks & Robertson) Lafuze 2nd – motion carried.
- o **Project to investigate** – (from previous mtg) – Drain @ Watts – Maplenut Dr. & McMinn. G. Kates – investigated the drain.Discussion on drainage. G. Kates to gather more information and bring to board at next meeting.
- o **Poplar Ave culvert** – update –Discussion on information given by ChoiceOne Engineering. Also a discussion on Mattie Harris culvert. G. Kates rec'd estimate to look at the Mattie Harris culvert, drainage swale and Stormwater detention basin.**Motion** by Killen to allow ChoiceOne to do the MattieHarris Road Culvert Analysis for \$3,390. Lafuze2nd – motion carried.
- o **Other** – Discussion on Winding Brook culvert – has quite a bit of debris that needs cleaned out.
 - Discussion on bridge/culvert at North Morton.Update from G. Kates – BLN is doing checks in Wayne County on bridges & culverts. They are to get with G.Kates(building commissioner) and look at North Morton bridge (by park). Updates to come from Kates.
