Old Business:

- -2 Mile fringe -same as last meeting- no movement at this time-new legislation to review.
- -Comprehensive Plan-discussed reaching out to Ball State University to see about getting a Grad Student to come and help amend our current Comprehensive Plan. Gene Kates has agreed to reach out to Ball State.
