### **Department Reports:**

- 1. Building Commissioner report given. 209 W Walnut Street the demolition may move forward if plan commission find necessary due to no agreement with bank and buyer.
- 2. Police Department report given: Tyler Green back from academy, will be raise in pay for him. Also, Dylan Lakes will be off probation so will also receive raise in the next payroll. Also placed ad in paper for new officer, Mathew Wright is leaving. Have been checking on RV parking on street, all are legally parked.
- 3. Fire Department report given on vest program moving forward. Town Attorney stated that needed to accept the donation on the vest program. *Jack made the motion to accept vest donations* 2<sup>nd</sup> by Josh motion carried. Update on fire and city building contract from architect will be e mailed. Dan to sign to move forward.

If granted would have to do phase one environmental study. A motion to accepted the April 12,2022 agreement that has no clause of indemnification was made by Gary 2<sup>nd</sup> by Josh ,motion carried.
