## RESOLUTION AUTHORIZING APPLICATION SUBMISSION AND LOCAL MATCH COMMITMENT

RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF CENTERVILLE, INDIANA, AUTHORIZING THE SUBMITTAL OF THE PUBLIC FACILITIES PROGRAM (PFP) APPLICATION TO THE INDIANA OFFICE OF COMMUNITY AND RURAL AFFAIRS AND ADDRESSING RELATED MATTERS

**WHEREAS,** the Town Council of the Town of Centerville, Indiana recognizes the need to stimulate growth and to maintain a sound economy within its corporate limits; and,

**WHEREAS,** the Housing and Community Development Act of 1974, as amended, authorizes the Office of Community and Rural Affairs to provide grants to local units of government to meet the housing and community development needs of low and moderate income persons; and,

WHEREAS, the Town of Centerville, Indiana has conducted or will conduct public hearings prior to the submission of an application to the Office of Community and Rural Affairs, said public hearings to assess the housing, public facilities and economic needs of its low and moderate income residents;

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Centerville, Indiana that:

Section 1: The Town Council President is authorized to prepare and submit an application for grant funding to address improvements to Centerville Fire Station No1. Improvements will include an addition of one truck bay, installation of exhaust system for existing and new truck bay, installation of a fire alarm system, and the rehabilitation of existing space to provide accessible men's and women's restrooms and showers and a larger training room, and to execute and administer a resultant grant including requisite general administration and project management, contracts and agreements pursuant to regulations of the Office of Community and Rural Affairs and the United States Department of Housing and Urban Development.

Section 2: That the Town of Centerville, Indiana hereby commits the requisite local funds in the amount of Two Hundred Twenty-five Thousand dollars, and no cents (\$225,000.00) from the following sources: \$225,000 from the Town of Centerville's General Fund as matching funds for said program, such commitments to be contingent upon receipt of PFP funding from the Office of Community and Rural Affairs.

Upon motion duly made and seconded, this Resolution is hereby passed and adopted by the Town Council of the Town of Centerville, Wayne County, Indiana this 28 <sup>th</sup>day of March, 2023.
